## **Rules and Regulations for Puttin Plus**

The students will rotate in groups to go-karts, batting cages, mini-golf and water tag (weather permitting). Any time remaining after the groups have participated at each station, will be your choice of activity. It is our intention that everyone should have a wonderful experience while attending our park. The following rules are to be followed to insure your safety.

Go-Karts: (1) Must be 8 years old and 52" tall.

- (2) No bumping on the track.
- (3) No wild driving (erratic).
- (4) When the ride is over you must enter the Pit Area SLOWLY. STOP!!!
- (5) Do not hit the car in front of you.
- (6) Do not get up until the Track Attendant says it is OK to get out of the KART.
- (7) If you do not comply with the rules you will be removed from the track and not be able to drive again.

# **Batting**: (1) Must wear helmet to bat. (one token at a time, when finished obtain another token to continue) (2) Enter or exit through batting cage doors only.

- (3) Only one batter at a time in a cage.
- (4) No swinging bats outside of cages.

### **<u>Golf</u>**: (1) No throwing golf clubs/ or swinging above the waist.

- (2) Stay on golf course walking areas.
- (3) No climbing on waterfalls or playing in the pond

**Water Tag:** (2) The game extends to out door.

(3) You will return to arena when the whistle blows- Do not jump through or roll over with equipment on.
